Ken Koskela Photography LLC strongly recommends that all participants purchase trip cancellation and interruption insurance to cover any non-refundable registration fees, travel, lodging, or other expense which you might incur in the event that an emergency or other event causes you to cancel or discontinue your participation in the workshop or expedition.

ACKNOWLEDGMENT OF RISK, WAIVER AND RELEASE OF LIABILITY AGREEMENT

By registering for any Ken Koskela Photography LLC workshop, private lesson, trip or tour (collectively hereinafter referred to as "TOUR") and by signing below, you acknowledge and certify that you (and/or your minor child) are voluntarily participating in activities that can include traveling to areas that may be remote or undeveloped and therefore may involve additional risks, dangers, and inconveniences that include the possibility of property damage, bodily injury and death. These include, but are not limited to: transportation by air, train, bus or other means; non-maintained roads and walkways; theft of personal property and other crimes; accidents; exposure to illnesses including tropical diseases and food-related illnesses; wild and venomous animals; lack of access to immediate, adequate and proper medical care; extreme weather conditions and geological events; exposure to high altitudes; political events or instabilities; and other circumstances and forces both natural and manmade. Additionally, you accept that travel and outdoor activity involves some inherent risk of injury, illness, loss or damage to personal property, and other safety-related dangers including death, whether by acts of nature or human negligence, including personal actions, or the actions of others.

By signing this agreement, you agree to assume all such risks and expressly release Ken Koskela, Ken Koskela Photography LLC, its contractors, agents, officers, tour leaders, representatives and associates (collectively hereinafter referred to as "THE OPERATOR") from any and all risks and losses associated with your (and/or your minor child's) participation. This includes holding THE OPERATOR harmless from any and all liability, damage claims, costs, and actions pertaining to any and all risks, accidents, deaths, injuries, illnesses, property damage or loss, delays, inconveniences, or other irregularities that may occur for any reason whatever directly or indirectly in conjunction with or arising from any workshop you participate in. Additionally, TOURS are

dependent upon other service providers including guides, drivers, hotels, restaurants and contractors providing acceptable services. You agree not to hold THE OPERATOR liable should any such service provider fail to provide services as advertised or anticipated.

THE OPERATOR reserves the right to cancel or change any activity, location, and to accept or reject any person as a member of any TOUR, at any time before or during the TOUR. This includes for the reason of having too few participants. THE OPERATOR is not responsible for any additional expenses you incur prior to the workshop including airfare, clothing, gear rental or any other related expense.

Participation in a TOUR requires that you are in good mental and physical condition. You agree that THE OPERATOR assumes no liability for the medical care, evacuation or dietary requirements for any participants and that THE OPERATOR has the right to disqualify a participant without refund if THE OPERATOR believes the participant's continued participation creates any risk for the participant or members of the group. THE OPERATOR's judgment shall provide the final determination of an individual's ability to participate in, or continue to participate in, any activity or TOUR. As a participant, you agree to refrain from threatening, unruly, disruptive, or criminal behavior and agree that THE OPERATOR has the authority to eject you from the tour without refund for doing so. You agree to hold THE OPERATOR harmless should such action be taken.

Should THE OPERATOR, or anyone acting on its behalf, be required to incur attorney's fees and costs to enforce this agreement, you agree to indemnify them and hold them harmless for all such fees and costs. If a lawsuit is filed you agree to do so in Du Page County, Illinois, USA. All legal matters relative to these terms and conditions as they affect any sponsoring organization shall be directed to and litigated only through the legal system designated by said sponsoring organization.

You undersigned understand that this document, once signed, shall serve as an assumption of risk, waiver, indemnity, and release by all signatories, their heirs, all members of their families including any minors accompanying the TOUR, executors, administrators, and any other representatives of the signatories. The undersigned further understand that the terms of this document are contractual and not merely advisory in nature. You also agree to the terms and provisions of the Enrollment Information, as stated in the Ken Koskela Photography website and materials pertaining to the trip, especially noting the Tour Policy material on cancellations, refunds, and limitations on responsibility.

If any part, article, paragraph, sentence or clause of this Agreement is not enforceable, the affected provision shall be curtailed and limited only to the extent necessary to bring it within the requirements of the law, and the remainder of the Agreement shall continue in full force and effect.
